

AN ORDINANCE AMENDING CHAPTER VII, "TRAFFIC", OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF SPARTA, AMENDING SECTION 7-17 "WEIGHT LIMIT"

WHEREAS, the Township of Sparta received a request from the Lake Mohawk Country Club requesting a weight restriction of 15 tons be imposed on the West Shore Trail Bridge over the Wallkill River; and

WHEREAS, Lake Mohawk Country Club provided the Township with a copy of the Engineering Report prepared by Genesis Engineering dated March 30, 2015 in support of the weight restriction; and

WHEREAS, the Police Chief and Township Engineer concur with Lake Mohawk County Club's weight restriction request; and

NOW, THEREFORE, BE IT ORDAINED by the Sparta Township Council, County of Sussex, State of New Jersey, that the revised General Ordinances of the Township of Sparta are amended as follows:

Section 1.

Township Ordinance Section 7-17, "Vehicles Over Designated Weight Excluded from Certain Streets" is hereby amended to include the following:

<i>Name of Street</i>	<i>Weight</i>	<i>Location</i>
West Shore Trail	15 tons	Bridge over the Wallkill River

Section 2. Severability. If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

Section 3. Repealer. All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

Section 4. Effective Date. This ordinance shall take effect after publication and passage according to law.
