## SEE REVERSE SIDE FOR ADDITIONAL INFORMATION

EACH TAX BILL REPRESENTS THE APPORTIONMENT OF EXPENSES FOR SUSSEX COUNTY, SPARTA TOWNSHIP, AND THE SPARTA BOARD OF EDUCATION.

TAX BILLS ARE MAILED OUT IN LATE JUNE OR EARLY JULY. THEY ARE DIVIDED INTO 4 QUARTERS. YOU WILL NOTE THAT THE FIRST TWO QUARTERS ARE LESS THAN THE SECOND TWO. THIS IS DUE TO THE FIRST HALF OF THE YEAR BEING BILLED AT HALF THE TAX OF THE PRECEEDING YEAR. THE SECOND HALF OF THE YEAR IS BASED ON THE NEW TAX RATE.

BUDGET REVIEW FOR ALL THREE PUBLIC BODIES IS DONE EARLY IN THE YEAR. SPARTA TOWNSHIP HOLDS A BUDGET HEARING EVERY MARCH. THE BOARD OF EDUCATION PUTS ITS BUDGET TO A PUBLIC VOTE EVERY APRIL. SUSSEX COUNTY ALSO HAS PUBLIC BUDGET HEARINGS.

THE TOWNSHIP HAS RECENTLY COMPLETED A RE-VALUATION OF ALL PROPERTIES. THESE NEW NUMBERS WILL BE THE BASIS OF YOUR 2002 TAX BILL. EACH PROPERTY OWNER HAS RECEIVED A NOTICE SETTING FORTH THE NEW ASSESSMENT FOR THEIR PROPERTY. ASSESSMENTS MAY BE APPEALED BY FILING WITH THE COUNTY BY APRIL 1ST OF EACH YEAR.
