

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF SPARTA AMENDING SECTION 18-4.24b ENTITLED ‘PRINCIPAL PERMITTED USES’ CHAPTER 18 ‘COMPREHENSIVE LAND MANAGEMENT CODE’ OF THE CODE OF THE TOWNSHIP OF SPARTA

Purpose Statement. The purpose of this Ordinance is to allow parking as a principal use in the Town Center Commercial (TCC) Zone for a homeowners association of at least 300 homeowners.

NOW, THEREFORE, BE IT ORDAINED that the Mayor and Council of the Township of Sparta hereby ordains as follows:

Section 1. Section 18-4.24b entitled “Principal Permitted Uses” of the TCC Zone is amended to add the following new subsection at the end of the section:

“11. A parking lot on property owned by a homeowners association with at least 300 members. Non-members of the association may be charged a user fee. Parking or a parking lot is otherwise prohibited as a principal use in the TCC Zone. This amendment does not extend to parking on public roadways and is limited to a parking lot.”

Section 2. Severability

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 3. Repealer

All Ordinances or parts of ordinances inconsistent herewith are repealed as to such inconsistencies.

Section 4. Effective Date

This Ordinance shall take effect upon passage and publication as provided by law.
