

**AN ORDINANCE AMENDING CHAPTER VII, "TRAFFIC",  
OF THE REVISED GENERAL ORDINANCES OF THE  
TOWNSHIP OF SPARTA, AMENDING SECTION 7-30  
"MID-BLOCK CROSSWALKS"**

**WHEREAS**, the Township of Sparta Council desires to amend the Township's existing Ordinance Chapter VII, "Traffic", Section 7-30 regarding mid-block crosswalks; and

**WHEREAS**, the Township Engineer and the Police Chief concur with the need to amend the Ordinance; and

**NOW, THEREFORE, BE IT ORDAINED** by the Sparta Township Council, County of Sussex, State of New Jersey, that the revised General Ordinances of the Township of Sparta are amended as follows:

**Section 1.**

Township Ordinance Section 7-30, "Mid-Block Crosswalks" is hereby amended to remove the following:

<i>Name of Street</i>	<i>Location</i>
White Lake Road	191 feet south of the southern curbline of Route 94, to a point 10 feet southerly therefrom
West Mountain Road	1717 feet north of the northern curbline of Route 517, to a point 10 feet northerly therefrom

**Section 2. Severability.** If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Section 3. Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

**Section 4. Effective Date.** This ordinance shall take effect after publication and passage according to law.
