

**AN ORDINANCE AMENDING CHAPTER II,  
“ADMINISTRATION” OF THE REVISED GENERAL  
ORDINANCES OF THE TOWNSHIP OF SPARTA**

**WHEREAS**, the Sparta Township Council desires to amend Chapter 2 “Administration”, Article IX “Committees; Boards; Commissions”, Section 2-39 “Environmental Commission”, Section 2-39.4 “Organization of Commission; Records; Meetings; Annual Report.” of the Revised General Ordinances of the Township of Sparta in order to change the meeting time from 8:00 p.m. to 7:00 p.m..

**NOW THEREFORE BE IT ORDAINED** by the Sparta Township Council that Chapter 2, “Administration”, Article IX, “Committees; Boards; Commissions”, Section 2-39, “Environmental Commission” is hereby amended as follows:

**Section 1. 2-39.4 - “Organization of Commission; Records; Meetings; Annual Report”**, subsection “a” is repealed and replaced as follows:

“The Commission shall meet on the 2<sup>nd</sup> and 4<sup>th</sup> Thursday of each month at 7:00 p.m., or at such times as requested by the Township Council.”

**Section 2. Severability.** If any provision of this ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Section 3. Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this ordinance are hereby repealed in their entirety.

**Section 4. Effective date.** This ordinance shall take effect after its final passage and publication as required by law.
