

**AN ORDINANCE AMENDING CHAPTER VII, "TRAFFIC",  
OF THE REVISED GENERAL ORDINANCES OF THE  
TOWNSHIP OF SPARTA, AMENDING SECTION 7-13  
"PARKING PROHIBITED AT ALL TIMES ON CERTAIN  
STREETS"**

**WHEREAS**, The Sparta Commons Condominium Association requested that the Sparta Township Council adopt an ordinance restricting parking to one side of the road on Wagon Wheel Road, Saddleback Court and Bridal Way within the Sparta Commons community;

**WHEREAS**, the Township's Police Department reviewed this matter and the Police Chief concurs with the Association's request, and suggested that Township Ordinance 7-13 be amended as provided in this Ordinance; and

**NOW, THEREFORE, BE IT ORDAINED** by the Sparta Township Council, County of Sussex, State of New Jersey, that the revised General Ordinances of the Township of Sparta are amended as follows:

**Section 1.**

Township Ordinance Section 7-13, "Parking Prohibited At All Times On Certain Road" is hereby amended to add the following:

<i>Name of Street</i>	<i>Side</i>	<i>Location</i>
Wagon Wheel Road	Inside portion of circle	Entire length
Saddleback Court	Left side and inside portion of circle	Entire length
Bridal Way	Left side	Entire Length

**Section 2. Severability.** If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Section 3. Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

**Section 4. Effective Date.** This ordinance shall take effect after publication and passage according to law.
