

**AN ORDINANCE AMENDING CHAPTER VII, "TRAFFIC", OF THE REVISED
GENERAL ORDINANCE OF THE TOWNSHIP OF SPARTA, AMENDING SECTION
7-17 "VEHICLES OVER DESIGNATED WEIGHT EXCLUDED FROM CERTAIN
STREETS"**

WHEREAS, the Township of Sparta Council desires to amend the Township's existing Ordinance Chapter VII, "Traffic", Section 7-17, "Vehicles Over Designated Weight Excluded From Certain Streets"; and

WHEREAS, the Township Engineer and the Police Chief concur with the need to amend the Ordinance; and

NOW, THEREFORE, BE IT ORDAINED by the Sparta Township Council, County of Sussex, State of New Jersey, that the revised General Ordinances of the Township of Sparta are amended as follows:

Section 1.

Township Ordinance Section 7-17, "Vehicles Over Designated Weight Excluded From Certain Streets" is hereby amended as follows:

a. Add:

<u>Name of Street</u>	<u>Weight</u>	<u>Location</u>
Fiddlers Way	4 tons	Entire length
McCloud Lane	4 tons	Entire length

Section 2. Severability. If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

Section 3. Repealer. All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

Section 4. Effective Date. This ordinance shall take effect after publication and passage according to law.
